**COUNCIL ACCEPTS ALABAMA MUNICIPAL INSURANCE CORPORATION PROPOSAL FOR GENERAL LIABILITY INSURANCE OVERAGE:**

Mayor Johnson called on City Clerk, John Thompson, to report to the council about the city's general liability and property insurance policy. Mr. Thompson said that the current policy had expired and that he had obtained quotes from two companies and discussed details concerning coverage, premiums, etc. Councilmember Mount moved to accept the proposal from the Alabama Municipal Insurance Corporation and to appropriate the difference between the budgeted amount for the premium and the actual premium from contingency. Councilmember Sconiers seconded the motion which passed unanimously.

**COUNCIL APPROVES HR2010-01, POLICE DEPARTMENT PERSONNEL CHANGES:**

Mayor Johnson presented HR2010-01, effecting personnel changes in the police department. Councilmember Jewell moved to approve HR2010-01. Councilmember Griffin seconded the motion which passed unanimously.

**COUNCIL DECLARES PROPERTIES A PUBLIC NUISANCE:**

Mayor Johnson presented properties located at: 200 King Street, 739 Auburn Avenue, 701 Dunson Street, 638 West Watson Street, 137 Railroad Avenue, 187 Railroad Avenue, 501 Brewton Street, 306 North Cotton Street, to the council that the planning and development department had identified in violation of the city's nuisance and abatement ordinances. Councilmember Griffin moved to declare these properties a public nuisance. Councilmember Mount seconded the motion which passed unanimously.
