APPROVAL OF MINUTES:

Mayor Johnson presented the minutes from the March 6, 2012, regular meeting. Councilmember Griffin moved to approve the minutes. Councilmember Powell seconded the motion which passed unanimously.

COUNCIL APPROVES VOTING DELEGATES FOR ALABAMA LEAGUE OF MUNICIPALITIES AND ALABAMA MUNICIPAL INSURANCE CORPORATION ANNUAL MEETINGS:

Mayor Johnson announced that it was necessary to designate a voting delegate and alternates for the business session of the annual meeting of the Alabama League of Municipalities. Councilmember Sconiers nominated Mayor Johnson to serve as voting delegate, Councilmember Powell as the first alternate and Councilmember Mount as the second alternate. Councilmember Griffin seconded the nominations which were approved unanimously.

COUNCIL APPROVES MURAL CONTRACT:

Pat Palmore, Chairman of the Mural Committee, made a presentation to the council about an early schools mural. Councilmember Powell moved to approve the concept of the mural and to authorize the mayor and city clerk to execute a contract with the artist and the property owner in order to complete the mural. Councilmember Griffin seconded the motion which passed unanimously.

COUNCIL APPROVES AGREEMENT WITH COVINGTON COUNTY COMMISSION FOR MIRACLE FIELD:
